

I, 8, cl. 3), to regulate it. In the 108th Congress, the House passed virtually identical bills (H. R. 5 and H. R. 4280) that would have preempted state law with respect to certain aspects of medical malpractice lawsuits, and it seems likely that the 109th Congress will also consider medical malpractice reform proposals.
